We Plan to

 Programs will be on a three-year cycle of review, which will include roundtable interviews (focus groups) with employers. These interviews will ascertain the perceptions of the employers regarding employer satisfaction as it relates to the preparation of the EPP's completers. Each fall, different programs will be reviewed.

1. Spring 2021, the Office of Field Experience and Assessment Coordinator will work with partner districts and LDOE to collect employer information and identify employers of the EPP's completers within the last three years. The interviews will be piloted with program coordinators and faculty as well as clinical faculty, who are experts in the respective fields. Adjustments to questions based on feedback will be made.

Zoom accounts (held by the university and personnel) will be utilized to conduct and record interview sessions. Faculty and staff relevant to each program will analyze the data.

Roundtable interview questions were developed to align with program-specific standards in Fall 2020. Each question was aligned to a set of specialty standards. In Spring 2021, the interview questions will be piloted with program coordinators and faculty as well as clinical faculty, who are experts in their respective fields.
